Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders representatives who choose to attend at 2:00 pm on 31<sup>st</sup> day (2020/11/18) of publication of notice at the Galchhi Rural Municipality Office, Baireni, Dhading, Bagmati Province, Nepal. Bids must be valid for a period of **90(Ninety) days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in PDF format in case of e-bid, amounting as specified below which shall be valid for 30th days beyond the validity period of the bid.
