

Invitation for Bids

Galchhi Rural Municipality Office invites electronic bids from eligible bidders for this year project for construction of **Syaltar-Dyunipokhari-Suntar-Fusremata-Dharmadwar-Paudwar-Barbhajyang sadak Starnnoti tatha Gravel, Ghimirethumka-Machedi-Palangkharka Hudai Ward no. 5 Jodne Bato Starnnoti and Dumre Archale Sadak Starnnoti Ward No. 2** works of Galchhi Rural Municipality at Baireni, Dhading under National competitive Bidding procedures.

2. Eligible Bidders may obtain further information and inspect the Bidding Documents at the Galchhi Rural Municipality Office, Baireni, Dhading, Bagmati Province, Nepal, or may visit PPMO website www.bolpatra.gov.np/egp.

4. Per-bid meeting shall be held at **Galchhi Rural Municipality Office**, **Baireni**, **Dhading**, **Bagmati Province**, **Nepal**, at 2:00 PM on 19th day (2020/11/06) of publication of notice.

Electronic bids must be submitted to the office Galchhi Rural Municipality Office, Baireni, Dhading, Bagmati Province, Nepal through PPMO website www.bolpatra.gov.np/egp on or before 12:00 Noon on 31st day (2020/11/18) of publication of notice. Bids received after this deadline will be rejected.

6. The bids will be opened in the presence of Bidders representatives who choose to attend at 2:00 pm on 31stday (**2020/11/18**) of publication of notice at the Galchhi Rural Municipality Office, Baireni, Dhading, Bagmati Province, Nepal. Bids must be valid for a period of **90(Ninety) days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in PDF format in case of e-bid, amounting as specified below which shall be valid for 30th days beyond the validity period of the bid Information to deposit the bid amount in Bank:

Non submission of the hard copy by the bidders within the specified time shall be considered as non- responsive and may cause for forfeiture of bid security.
