- Galchhi Rural Municipality invites electronic bids from Nepalese eligible bidders for the **Construction of Chief Administrative Office Building** under National Competitive Bidding Single Stage Two Envelope Bidding procedures.
- Only eligible bidders with the following key qualifications should participate in this bidding:  
Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 9,50,00,000 (Nrs. Nine Crores and Fifty Lakh Only)  
Minimum Work experience of similar size and nature: Minimum one Building Construction Works of Value more than 7,55,00,000.00 (Seven Crore Fifty Five Lakh only).
- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

- Pre-bid meeting shall be held at Galchhi Rural Municipality, Bairani, Galchhi, Dhading at 2:00 PM on 12<sup>th</sup> May 2023 AD.
- Electronic bids must be submitted through PPMO website [www.bolpatra.gov.np](http://www.bolpatra.gov.np). on or before **12:00 PM on 28<sup>th</sup> May 2023 AD**. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on **28<sup>th</sup> May 2023 AD** at the office of Galchhi Rural Municipality, Bairani, Galchhi, Dhading. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in PDF format in case of e-bid, amounting to a minimum of **Npr. 32,00,000/- (Thirty Two Lakh Only)**, which shall be valid for 30 days beyond the validity period of the bid (For bidder who want to deposit cash as bid security can deposit in the dharauti khata of Galchhi Rural Municipality mentioned in the bid document).
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- The Employer reserve the right to accept or reject, wholly or partly any or all the bids without assigning reason whatsoever.
- Matters not covered by this notice shall be in accordance with Bid document, PPA and PPR and its amendments.
