1. **Galchhi Rural Municipality** invites sealed bids or electronic bids from Nepalese eligible bidders for the construction of **Aduwabari-Batase-Bhaltar-Chariamile-Ratmate-Kamitol-Dhungantar-Mastar Water Supply Project** under National Competitive Bidding procedures.
2. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Galchhi Rural Municipality, Bairani, Galchhi, Dhading** or may visit PPMO website www.bolpatra.gov.np/egp.
3. Eligible Bidder may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp,. Bidders, submitting their bid electronically, should deposit the cost of NPr.3000.00 of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at **Galchhi Rural Municipality, Bairani, Galchhi, Dhading at 2:00 PM on 21th (20/12/2020 AD) days of publication of notice.**
5. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np. on or before 12:00 PM on 31-12-2020 AD. Bids received after this deadline will be rejected. Submitting their bid electronically, should deposit the non-refundable fee as mentioned below and scanned copy of written application. Along with the copy of company/firm registration certificate, tax clearance certificate up to FY076/77 or Letter of approved of extension of tax clearance and other necessary document.
6. The bidswill be opened in the presence of Bidders' representatives who choose to attend at **2:00 PM** on 31-12-2020 AD at the office of **Galchhi Rural Municipality, Bairani, Galchhi, Dhading**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in PDF format in case of e-bid, amounting to a minimum of **Npr. 2,50,000/-**, which shall be valid for 30 days beyond the validity period of the bid information to deposit bid amount in bank as specified.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. The Employer reserve the right to accept or reject, wholly or partly any or all the bids without assigning reason whatsoever.
9. Matters not covered by this notice shall be in accordance with Bid document, PPA and PPR.
